

Probation revoked for hit-run suspect Her arrest violated terms of program

This is what we call an unfortunate visual image:

The restaurant owner accused of a high-profile, fatal hit-and-run, leaving a **court** hearing by careening wildly across the busy city street in front of the Criminal Justice Center.

Pursued by TV reporters, **Susanna Goihman** - charged, so far, with fleeing the scene of Kayla Peter's June 19 traffic death in East Falls - took off in a hurry after her probation was revoked for a January drunk-driving case.

Just weeks before Peter's death, **Goihman** - charged with DUI after a January fender-bender - was admitted into a special program for first-time, nonviolent offenders. Her arrest for fleeing the scene of the accident that killed 15-year-old Peter was a direct violation of the terms of her Accelerated Rehabilitative Disposition, or ARD, said prosecutor Mark Gilson.

"As a result of her arrest, she was removed from ARD," Gilson said.

Gilson stressed that, given the circumstances of **Goihman's** first arrest, she was eligible for the ARD program.

"No one knew that two weeks later," he said.

Goihman now must stand trial on Nov. 21 for the January DUI charge.

Neither **Goihman** nor her attorney, Brian McMonagle, commented on the case.

During her brief **court** appearance yesterday, **Goihman** - eschewing her infamous Mickey Mouse sweatshirt in favor of a black shirt and black pin-striped pants - walked slowly and limped, appearing to have an injured foot. When asked after **court** if she had hurt herself, **Goihman** nodded yes.

She recovered fast. Within minutes, **Goihman** was weaving in and out of cars, making that desperate dart to avoid the TV news cameras.

Gilson said a grand jury is continuing its investigation into the accident. He declined to discuss details of that investigation.

"We are certainly exploring all the circumstances surrounding what occurred in the Kayla Peter hit-and-run," he said.

Sources have said police and the grand jury are trying to determine if **Goihman** was drunk at the time of the accident. In the January case, her blood-alcohol level was twice the legal limit, Gilson said.

Goihman was arrested on Jan. 2 at 11:30 p.m. and charged with drunken driving after her car bumped the back of another vehicle in a Burger King parking lot on Cheltenham Avenue. Officers at the scene said **Goihman** smelled of alcohol and appeared to be intoxicated.

"It's a very strong case," Gilson said.
